Lake Management

- Help to prepare the Lake for opening; ensuring all buildings are open and clean and that all safety equipment is put out.
- Clean of all areas used by members (changing rooms, toilets, showers and Club house), and ensuring that these are appropriately stocked.
- Ensure that all members and their guests are admitted to the Lake in accordance with current instructions as set out in the staff manual and Club rules.
- Ensure the safe monitoring of the swimmers and swimming area taking appropriate responsibility for the Health and Safety of members and their guests.
- Ensure that Health and Safety procedures are followed, as set down in Normal Operating Procedures (NOP).
- Ensure swimming tests for new members and junior guests are carried out correctly.
- Ensure that proper standards of work are maintained to ensure a good standard of service is always provided to members.
- Ensure all matters of immediate concern are brought to the attention of the shift Lead.
- Clear the Lake of members before closing, putting all safety equipment away and locking all building and the front gate.

Health & Safety

- To have a good knowledge of the Club rules, by laws, policies and procedures and always apply these.
- Ensure that procedures are followed, as set down in the Club's Staff Manual.
- To be up to date with all in house and online training requirements.
- To attend monthly training sessions.

Communication

- Communicate with members and their guests in a polite and effective manner.
- Deal efficiently with enquiries from prospective members, and members of the public.
- Resolve or report any issues, complaints that arise, this may include member behaviour, damage to equipment etc.
- Reply to emails or communications from the operation team in a timely manner.
